Data Protection Impact Assessment

GDPR provides for a mandatory DPIA when the processing activity is likely to result in a high risk to the rights and freedoms of natural persons (for instance, processing on a large scale of special categories of data, systematic monitoring of a publicly accessible area on a large scale, etc.). MGSI relies on its expertise in data protection and in risk analysis to assist you in carrying out a DPIA.
